17	Subtitle
18	TO CREATE THE AUTOMATIC OCCUPATIONAL
19	LICENSURE FOR OUT-OF-STATE INDIVIDUALS
20	ACT.
21

23	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
24	
25	SECTION 1. Arkansas Code Title 17, is amended to add an additional
26	chapter to read as follows:
27	CHAPTER 7 - AUTOMATIC OCCUPATIONAL LICENSURE FOR OUT-OF-STATE INDIVIDUALS ACT
28	
29	17-7-101. Title.
30	This chapter shall be known and may be cited as the "Automatic
31	Occupational Licensure for Out-of-State Individuals Act".
32	
33	17-7-102. Definitions.
34	As used in this chapter:
35	(1) "Automatic occupational licensure" means the granting of
36	occupational licensure to an individual who establishes residency in this

1	state without the individual's having met occupational licensure requirements
2	provided under this title or by the rules of the relevant occupational
3	licensing entity;
4	(2) "Occupational licensing entity" means an office, board,
5	commission, department, council, bureau, or other agency of state government
6	having authority to license, certify, register, permit, or otherwise
7	authorize an individual to engage in a particular occupation or profession,
8	not including occupations or professions within the judicial branch of
9	government or occupations or professions subject to the superintending
10	control of the Supreme Court; and
11	(3) "Occupational licensure" means a license, certificate,
12	registration, permit, or other form of authorization required by law or rule
13	that is required for an individual to engage in a particular occupation or
14	profession.
15	
16	17-7-103. Applicability.
17	Unless otherwise stated in this chapter, this chapter applies to an
18	individual who has occupational licensure in another state, territory, or
19	district of the United States and has established a residence in this state.
20	
21	17-7-104. Automatic occupational licensure.
22	(a) If the individual does not have a disqualifying criminal offense
23	under § 17-3-102 or any additional state law relating to the occupational
24	licensure and does not have a complaint, allegation, or investigation pending
25	for his or her occupational activity, an occupational licensing entity shall
26	grant automatic occupational licensure to engage in an occupation or a
27	profession to an individual who is:
28	(1) The holder in good standing for one (1) year of an
29	occupational licensure with similar scope of practice issued by another
30	state, territory, or district of the United States; or
31	(2) An individual who worked:
32	(A) In another state, territory, or district of the United
33	States that does not use an occupational licensure to regulate an occupation
34	or profession but is regulated by occupational licensure in this state; and
35	(B) At least three (3) years in the occupation.
36	(b) An individual who is granted automatic occupational licensure

1	under this subchapter shall meet all occupational licensure requirements for
2	renewal of the occupational licensure, including without limitation a
3	criminal background check and continuing education hours.
4	(c) Notwithstanding subsections (a) and (b) of this section, an
5	occupational licensing entity may require an applicant to:
6	(1) Pass an examination specific to relevant state laws that
7	regulate the occupation or profession; and
8	(2) Furnish a bond, financial statement, and proof of insurance
9	coverage.
10	(d) An occupational licensing entity may waive the requirements of
11	subdivision (c)(1) of this section if the occupational licensing entity finds
12	<u>that:</u>
13	(1) The combination of the applicant's education, training, and
14	experience is a sufficient substitute for the requirement; and
15	(2) A waiver of the requirement will not harm public health,
16	safety, or welfare.
17	
18	17-7-105. Responsibilities of occupational licensing entities.
19	An occupational licensing entity shall:
20	(1) Provide automatic occupational licensure to an individual
21	<u>listed in § 17-7-104;</u>
22	(2) Post prominently on the occupational licensing entity's
23	website a link entitled "Out-of-State Licensure" that leads directly to
24	information applicable to an individual licensed under § 17-7-104; and
25	(3) Provide to the Legislative Council an annual report stating
26	the number of individuals granted automatic occupational licensure under this
27	<u>chapter.</u>
28	
29	<u>17-7-106. Exemptions.</u>
30	This subchapter does not apply to licensure or certification of:
31	(1) Medical professions under Title 17, Subtitle 3;
32	(2) Legal professionals; or
33	(3) Individuals under multistate or interstate compacts.
