18	TO CREATE THE AUTOMATIC OCCUPATIONAL
19	LICENSURE FOR OUT-OF-STATE INDIVIDUALS

23	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

25	SECTION 1. Arkansas Code Title 17, is amended to add an additional
26	chapter to read as follows:
27	CHAPTER 7 - AUTOMATIC OCCUPATIONAL LICENSURE FOR OUT-OF-STATE INDIVIDUALS ACT
28	
29	17-7-101. Title.
30	This chapter shall be known and may be cited as the "Automatic
31	Occupational Licensure for Out-of-State Individuals Act".
32	17.7.100
33	17-7-102. Definitions.
34	As used in this chapter:
35 36	(1) "Automatic occupational licensure" means the granting of occupational licensure to an individual who establishes residency in this
าท	occupational incensure to an individual WNO establishes residency in this

1	state without the individual's having met occupational licensure requirements
2	provided under this title or by the rules of the relevant occupational
3	licensing entity;
4	(2) "Occupational licensing entity" means an office, board,
5	commission, department, council, bureau, or other agency of state government
6	having authority to license, certify, register, permit, or otherwise
7	authorize an individual to engage in a particular occupation or profession,
8	not including occupations or professions within the judicial branch of
9	government or occupations or professions subject to the superintending
10	control of the Supreme Court; and
11	(3) "Occupational licensure" means a license, certificate,
12	registration, permit, or other form of authorization, including without
13	limitation military occupational specialty, required by law or rule that is
14	required for an individual to engage in a particular occupation or
15	profession.
16	
17	17-7-103. Applicability.
18	Unless otherwise stated in this chapter, this chapter applies to an
19	individual who has occupational licensure in another state, territory, or
20	district of the United States and has established a residence in this state.
21	
22	17-7-104. Automatic occupational licensure.
23	(a) If the individual does not have a disqualifying criminal offense
24	under § 17-3-102 or any additional state law relating to the occupational
25	licensure and does not have a complaint, allegation, or investigation pending
26	for his or her occupational activity, an occupational licensing entity shall
27	grant automatic occupational licensure to engage in an occupation or a
28	profession to an individual who is:
29	(1) The holder in good standing for one (1) year of an
30	occupational licensure with similar scope of practice issued by another
31	state, territory, or district of the United States; or
32	(2) An individual who worked:
33	(A) In another state, territory, or district of the United
34	States that does not use an occupational licensure to regulate an occupation
35	or profession but is regulated by occupational licensure in this state; and
36	(B) At least three (3) years in the occupation.

1	(b) An individual who is granted automatic occupational licensure
2	under this subchapter shall meet all other occupational licensure
3	requirements for a resident of this state and all renewal requirements of the
4	occupational licensure, including without limitation a criminal background
5	check and continuing education hours.
6	(c) Notwithstanding subsections (a) and (b) of this section, an
7	occupational licensing entity may require an applicant to:
8	(1) Pass an examination specific to relevant state laws that
9	regulate the occupation or profession; and
10	(2) Furnish a bond, financial statement, and proof of insurance
11	coverage.
12	(d) An occupational licensing entity may waive the requirements of
13	$\underline{subdivision}$ (c)(1) of this section if the occupational licensing entity finds
14	<u>that:</u>
15	(1) The combination of the applicant's education, training, and
16	experience is a sufficient substitute for the requirement; and
17	(2) A waiver of the requirement will not harm public health,
18	safety, or welfare.
19	
20	17-7-105. Responsibilities of occupational licensing entities.
21	An occupational licensing entity shall:
22	(1) Provide automatic occupational licensure to an individual
23	<u>listed in § 17-7-104;</u>
24	(2) Post prominently on the occupational licensing entity's
25	website a link entitled "Out-of-State Licensure" that leads directly to
26	information applicable to an individual licensed under § 17-7-104; and
27	(3) Provide to the Legislative Council an annual report stating
28	the number of individuals granted automatic occupational licensure under this
29	<u>chapter.</u>
30	
31	17-7-106. Exemptions — Construction.
32	(a) This subchapter does not apply to licensure or certification of:
33	(1) Medical professions under Title 17, Subtitle 3;
34	(2) Legal professionals; or
35	(3) Individuals under reciprocity agreements.
36	(b) This subchapter does not apply to an existing multistate or

1	interstate compact if the subchapter would result in a nullification of the
2	multistate or interstate compact.
