Disbursement of funds 21 22 authorized by this act shall be limited to the appropriation for such agency 23 and funds made available by law for the support of such appropriations; and 24 the restrictions of the State Procurement Law, the General Accounting and 25 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary 26 Procedures and Restrictions Act, or their successors, and other fiscal 27 control laws of this State, where applicable, and regulations promulgated by 28 the Department of Finance and Administration, as authorized by law, shall be 29 strictly complied with in disbursement of said funds. 30 SECTION 19. LEGISLATIVE INTENT. It is the intent of the General 31 32 Assembly that any funds disbursed under the authority of the appropriations 33 contained in this act shall be in compliance with the stated reasons for 34 which this act was adopted, as evidenced by the Agency Requests, Executive

4	SECTION 20. EMERGENCY CLAUSE. It is found and determined by the
5	General Assembly, that payees listed in this Act may be entitled to the sums
6	appropriated and transferred to herein, and that they have been deprived of
7	the use of these funds for a long period of time, and that further delay in
8	paying these just debts of the state would do harm to the reputation of the
9	State of Arkansas. Therefore, an emergency is hereby declared to exist and
10	this Act being necessary for the immediate preservation of the public peace,
11	health and safety shall be in full force and effect from and after the date
12	of its passage and approval.
13	If the bill is neither approved nor vetoed by the Governor, it shall become
14	effective on the expiration of the period of time during which the Governor
15	may veto the bill. If the bill is vetoed by the Governor and the veto is
16	overridden, it shall become effective on the date the last house overrides
17	the veto.
