SECTION 2. Under the authority granted by Arkansas Constitution,
Amendment 51, § 19, Arkansas Constitution, Amendment 51, § 8(a), concerning
the processing of voter registration applications, is amended to read as
follows:

7 (a)(1) The Office of Driver Services, State Revenue Offices state 8 revenue offices, public assistance agencies, disabilities agencies, and other 9 voter registration agencies shall transmit all completed voter registration 10 applications to the Secretary of State in sufficient time to allow the 11 Secretary of State to transmit the applications to the appropriate permanent 12 registrar no later than ten (10) days after the date of acceptance by the 13 assisting agency. When applications are accepted within five (5) days before 14 the last day of for an election under Arkansas Constitution, Amendment 51, § 15 9(b)(1), they must be transmitted no later than five (5) days after the date 16 of acceptance at the assisting agency.

17 (2) The Secretary of State shall transmit all mail voter 18 registration applications to the appropriate permanent registrar no later 19 than ten (10) days after the date of receipt. When applications are received 20 within five (5) days before the last day of pre-election registration for an election under Arkansas Constitution, Amendment 51, § 9(b)(1), they must be 21 22 transmitted no later than five (5) days after date of receipt. If forms are 23 received by the wrong election office, they shall be forwarded to the 24 appropriate permanent registrar not later than the fifth day after receipt. 25

SECTION 3. Under the authority granted by Arkansas Constitution,
Amendment 51, § 19, Arkansas Constitution, Amendment 51, § 9(b), concerning
the voter registration deadline, is amended to read as follows:

(b)(1) Except as otherwise provided in subdivision (b)(2) of this section, Registration registration shall be in progress at all times except during the thirty-day period immediately prior to any election scheduled within the county, during which period registration of voters shall cease for that election, but registration during such period shall be effective for subsequent elections.

35 36 (2) Registration shall be permitted:

(A) During early voting for a person appearing in person

1 at an early voting location; and 2 (B) On election day for a person appearing in person at a 3 polling site or a vote center established in his or her county of residence. 4 5 SECTION 4. Under the authority granted by Arkansas Constitution, 6 Amendment 51, § 19, Arkansas Constitution, Amendment 51, § 9(c)(2), 7 concerning voter registration submitted to the permanent registrar, is 8 amended to read as follows: 9 (2) Any person who assists applicants with a voter registration application as part of a voter registration drive or who, in furtherance of a 10 voter registration drive, gathers or possesses completed applications for 11 12 submission to the permanent registrar or Secretary of State shall deliver all 13 applications in his or her possession to the permanent registrar or Secretary 14 of State within twenty-one (21) days of the date on the voter registration 15 application and, in any event, no later than the deadline for pre-election 16 voter registration for the next election under Arkansas Constitution, 17 Amendment 51, § 9(b)(1). 18 19 SECTION 5. Under the authority granted by Arkansas Constitution, 20 Amendment 51, § 19, Arkansas Constitution, Amendment 51, § 10(b)(2), 21 concerning updating voter registration, is amended to read as follows: 22 (2) (A) If the updated registration information is actually 23 received in the office of the county clerk of the voter's new county not 24 later than four (4) days before a scheduled election, the voter shall have 25 the right to vote in the scheduled election in the precinct into which the 26 voter just moved in the new county. 27 (B) If the updated registration information is not 28 actually received by the fourth day before a scheduled election, the voter 29 shall not be eligible to vote in the scheduled election may update his or his 30 voter registration in accordance with subsection (g) of this section. 31 32 SECTION 6. Under the authority granted by Arkansas Constitution, Amendment 51, § 19, Arkansas Constitution, Amendment 51, § 10(c), concerning 33 34 the deadline to change legal residence on voter registration, is amended to 35 read as follows: 36 (c) If the change of legal residence is made pursuant to subsection

1 (a) or subdivision (d)(l) of this section following the deadline for preelection voter registration during the thirty-day administrative cut-off 2 3 period under Arkansas Constitution, Amendment 51, § 9(b)(1) immediately prior 4 to any election scheduled within the county, the registered voter shall 5 retain his or her right to vote in the scheduled election in the precinct to 6 which he or she just moved. 7 8 SECTION 7. Under the authority granted by Arkansas Constitution, 9 Amendment 51, § 19, Arkansas Constitution, Amendment 51, § 10, concerning 10 transfer and change of status for voter registration, is amended to add an additional subsection to read as follows: 11 12 (g) A person appearing in person on election day or during early 13 voting at an open polling site, a vote center, or an early voting location established in his or her county of residence may update his or her voter 14 15 registration on the same day as his or her appearance in accordance with § 7-16 5-113. 17 18 SECTION 8. Arkansas Code § 7-1-113(c)(3), concerning duties of an 19 election official before a person is permitted to cast a vote at a vote 20 center, is amended to read as follows: 21 (3) If the voter's name or address is not the same as that in 22 the county voter registration record files, request that the voter complete 23 an updated voter registration application form in accordance with § 7-5-113; 24 and 25 SECTION 9. Arkansas Code Title 7, Chapter 5, is amended to add an 26 27 additional section to read as follows: 28 7-5-113. Voter registration on election day or during early voting. 29 (a) A person appearing in person on election day or during early 30 voting at an open polling site, a vote center, or an early voting location 31 established in his or her county of residence is eligible to register to vote 32 or update registration on the same day as his or her appearance. (b) To register or update registration and vote under subsection (a) 33 of this section: 34 35 (1) The person shall: 36 (A) Register in the manner set forth by Arkansas
