17	(a)(1) Within thirty (30) days of the initial incarceration of a		
18	veteran of the United States Armed Forces whose sentence of incarceration is		
19	sixty (60) days or more, the administrator of the correctional facility with		
20	custody of the veteran shall mail written notice of the veteran's		
21	incarceration to the Arkansas Department of Veterans Affairs.		
22	(2) At least sixty (60) days prior to the release from		
23	incarceration of a veteran of the United States Armed Forces whose sentence		
24	of incarceration is sixty (60) days or more, the administrator of the		
25	correctional facility with custody of the veteran shall mail written notice		
26	of the veteran's release from incarceration to the Arkansas Department of		
27	Veterans Affairs.		
28	(b)(1) The sheriff of each county and chief of police responsible for		
29	each city jail shall inquire as a part of the intake procedure for each		
30	inmate whether the inmate is a veteran of the United States Armed Forces.		
31	(2) The sheriff of each county and chief of police responsible		
32	for each city jail shall develop procedures to ensure compliance with this		
33	section, including the use of a form designated for the notification of		
34	incarceration of a veteran by the Arkansas Department of Veterans Affairs.
