4	participate in the State and Public School Life and Health Insurance Program,		
5	is amended to read as follows:		
6	(g)(l) The following persons are eligible to participate in the

8	(A) A public school employee who is in a position that		
9	requires on average at least thirty (30) hours per week of actual performance
