31	of the Division of Arkansas State Police.	
32	(b) They <u>An ex officio deputy</u> shall be	subject to the duties and
33	obligations imposed by law in fire prevention	and in the investigation of the

36	SECTION 2. Arkansas Code § 12-13-112(a)	, concerning inquiries for fire



1	investigations, is amended to read as follows:
2	(a)(1) When the Director of the Division of Arkansas State Police or
3	any officer or deputy has reason to believe that a crime or other offense has
4	been committed in connection with any fire, the director or his or her deputy
5	may conduct an inquiry in relation thereto.
6	(2) The State Fire Marshal may request that the Division of
7	Arkansas State Police conduct an inquiry under this section if he or she has
8	reason to believe arson has been committed.
