27	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS	:

29	SECTION 1. DO NOT CODIFY. <u>Title.</u>	
30	This act shall be known and may be cited as the "Only Ci	<u>tizens Vote</u>
31	<u>Act".</u>

33	SECTION 2. Under the authority permitted under Arkansas	Constitution,
34	Amendment 51, § 19, Arkansas Constitution, Amendment 51, § 13(	Ъ)(1)(C),
35	concerning verification of voter registration, is amended to r	ead as follows:
36	(C) Documents and identification cards that	comply with



1 the requirements of subdivision (b)(1)(A) of this section include without 2 limitation: 3 (i) A driver's license, except as provided by 4 Arkansas Code § 27-16-801(b)(2)(C); 5 (ii) A photo identification card; 6 (iii) A concealed handgun carry license; 7 (iv) A United States passport; 8 (v) An employee badge or identification document 9 issued by an accredited postsecondary educational institution in the State of 10 Arkansas; 11 (vi) A United States military identification 12 document; 13 (vii) A public assistance identification card if the 14 card shows a photograph of the person to whom the document or identification 15 card was issued; and 16 (viii) A voter verification card under Arkansas Code 17 § 7-5-324. 18 19 SECTION 3. Arkansas Code § 7-1-101(40)(C)(i), concerning the documents 20 and identification cards that meet the definition of "verification of voter 21 registration" used in relation to elections, is amended to read as follows: 22 (i) A driver's license, except as provided under § 23 27-16-801(b)(2)(C); 24 25 SECTION 4. Arkansas Code § 7-4-109(e)(2)(D), concerning the 26 qualifications of state and county election commissioners, election 27 officials, poll workers, and certified election monitors, is amended to read 28 as follows: 29 (D)(i) The State Board of Election Commissioners shall 30 promulgate rules under the Arkansas Administrative Procedure Act, § 25-15-201 31 et seq., concerning the training requirements, materials, and examination of 32 essential skills. (ii) The training required under subdivision 33 34 (e)(2)(D)(i) of this section shall include instruction on recognizing and 35 refusing the acceptance of driver's licenses that are not valid for voter 36 identification purposes under § 27-16-801(b)(2)(C).

2	SECTION 5. Arkansas Code Title 7, Chapter 5, Subchapter 1, is amended
3	to add an additional section to read as follows:
4	7-5-113. Reporting of persons holding a noncitizen driver's license.
5	(a) The Secretary of the Department of Finance and Administration
6	shall prepare and deliver to the Secretary of State a monthly report listing
7	the names and identifying information of each person holding a driver's
8	license who has a valid, unexpired nonimmigrant visa or nonimmigrant visa
9	status for entry into the United States.
10	(b)(1) Upon receipt of the report prepared under subsection (a) of
11	this section, the Secretary of State shall verify if any person listed in the
12	report is listed in the voter registration record files maintained by the
13	Secretary of State.
14	(2) If a person listed in the Secretary of the Department of
15	Finance and Administration's monthly report is found to be registered as a
16	voter in the Secretary of States's voter registration record files:
17	(A) The Secretary of State shall notify the county clerk
18	of the county in which the person is registered to vote of the identity of
19	that person;
20	(B) The county clerk of the county who receives
21	notification of a person under subdivision (b)(2)(A) of this section shall
22	cancel the registration to vote of the person identified under subdivision
23	(b)(2)(A) of this section; and
24	(C) The Secretary of State shall notify the Secretary of
25	the Department of Finance and Administration of the identity of a person who
26	was found to be registered as a voter in the Secretary of State's voter
27	registration files and who had their voter registration canceled under
28	subdivision (b)(2)(B) of this section.
29	(c) Upon a notification under subdivision (b)(2)(A) of this section,
30	the Secretary of the Department of Finance and Administration shall
31	immediately suspend the driver's license of the person who is listed in the
32	Secretary of the Department of Finance's monthly report and is registered as
33	a voter in the voter registration record files maintained by the Secretary of
34	<u>State under § 27-16-907.</u>

36	SECTION 6. Arkansas Code § 27-16-801(a)(1), effective February 1,

2025, concerning the types of licenses that may be issued by the Office of 1 2 Driver Services, is amended to add an additional subdivision to read as 3 follows: 4 (C) A license issued to a person who has a valid, 5 unexpired nonimmigrant visa or nonimmigrant visa status for entry into the 6 United States shall expire no later than the expiration date of the valid, 7 unexpired nonimmigrant visa or nonimmigrant visa status for entry into the 8 United States. 9 SECTION 7. Arkansas Code § 27-16-801(b)(1), effective February 1, 10 2025, concerning the contents required to be contained on the face of a 11 12 driver's license, is amended to add an additional subdivision to read as 13 follows: 14 (C) If the licensee has a valid, unexpired nonimmigrant 15 visa or nonimmigrant visa status for entry into the United States, the license shall clearly display on its face the phrase "Non-Citizen". 16 17 18 SECTION 8. Arkansas Code § 27-16-801(b)(2)(C), effective February 1, 19 2025, concerning the purposes for which a driver's license is valid, is 20 amended to read as follows: 21 (C)(i) A license issued under subdivision (a)(1)(C) or 22 subdivision (b)(2)(B) of this section is not valid for: 23 (a) Federal identification purposes; or 24 (b) Voter identification purposes. 25 (ii) The license issued under subdivision (a)(l)(C) 26 or subdivision (b)(2)(B) of this section shall clearly display on its face 27 the phrase "Not valid for federal identification purposes or voter 28 identification purposes". 29 30 SECTION 9. Arkansas Code § 27-16-801(e), effective February 1, 2025, 31 concerning the administrative requirements for the issuance of a driver's 32 license, is amended to add an additional subdivision to read as follows: (6)(i) A license issued to a person who has a valid, unexpired 33 34 nonimmigrant visa or nonimmigrant visa status for entry into the United 35 States shall be distinctive in appearance from the regular driver's license 36 issued to a person who is twenty-one (21) years of age or older.

2	unexpired nonimmigrant visa or nonimmigrant visa status for entry into the
3	United States shall be printed in a vertical or portrait format.

5	SECTION 10. Arkansas Code § 27-16-907(b), concerning the basis for
6	suspending a license by the Office of Driver Services, is amended to add an
7	additional subdivision to read as follows:
8	(9) Was found by the Secretary of State under § 7-5-113 to be:
9	(A) Registered as a voter in the voter registration record
10	files maintained by the Secretary of State; and
11	(B) Listed in the monthly report of the Secretary of the
12	Department of Finance and Administration listing each person holding a
13	driver's license who has a valid, unexpired nonimmigrant visa or nonimmigrant
14	visa status for entry into the United States.
