SECTION 2. Arkansas Code § 20-10-2302 is amended to read as follows: 20-10-2302. Definitions. As used in this subchapter, "private care agency" means a provider that is certified by the Division of Provider Services and Quality Assurance as a provider of home- and community-based health services licensed by the Department of Health as a private care agency and that: (1) Furnishes in-home staffing services for personal and attendant care services for which the provider seeks reimbursement through the Arkansas Medicaid Program; and (2) Retains liability insurance of not less than one million dollars (\$1,000,000) to cover its employees and independent contractors while its employees and independent contractors are engaged in providing personal and attendant care services. SECTION 3. Arkansas Code § 20-10-2304(c)(3)(B), concerning the rules for private care agencies, is amended to read as follows: (B) A private care agency maintain a primary location in Arkansas and a sufficient number of regional offices to adequately service the administrative needs of the private care agency and the patients of the private care agency; and
