21	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23	SECTION 1. Arkansas Code § 12-19-102(a), concerning establishments
24	that are required to post information about the National Human Trafficking
25	Hotline, is amended to read as follows:
26	(a) The following establishments shall post in <u>restrooms and in</u> a
27	conspicuous place near the entrance of the establishment, or where posters
28	and notices of this type customarily are posted, a poster described in
29	subsection (b) of this section measuring at least eight and one-half inches
30	by eleven inches (8½" x ll") in size:
31	(1) A hotel, motel, or other establishment that has been cited
32	as a public nuisance for prostitution under § 20-27-401;
33	(2) A strip club or other sexually oriented business;
34	(3) A private club that has a liquor permit for on-premises
35	consumption and does not hold itself out to be a food service establishment;
36	(4) An airport;

3	(7) (6) A privately owned and operated facility that provides
