10	CODE CONCERNING THE ARKANSAS BETTER CHANCE PROGRAM

14	Subtitle
15	TO AMEND VARIOUS PROVISIONS OF THE
16	ARKANSAS CODE CONCERNING THE ARKANSAS
17	BETTER CHANCE PROGRAM ACT.
18	
19	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
20	
21	SECTION 1. DO NOT CODIFY. <u>Legislative findings and intent.</u>
22	(a) The General Assembly finds that:
23	(1) Preschool is an essential resource and component in the
24	State of Arkansas that is necessary to prepare young children to adequately
25	participate in a learning environment in elementary education;
26	(2) Currently, the Arkansas Better Chance Program and Arkansas
27	Better Chance for School Success Program have twenty-three thousand (23,000)
28	available preschool slots between the two programs;
29	(3) It is in the best interest of Arkansas's families and
30	childcare providers to combine the Arkansas Better Chance Program and
31	Arkansas Better Chance for School Success Program to promote efficiency in
32	the use and administration of the programs; and
33	(4) The qualifications for eligibility to participate in the
34	Arkansas Better Chance Program and Arkansas Better Chance for School Success
35	Program should be established by the Division of Elementary and Secondary
36	Education and should be the same qualifications for eligibility to

1 participate in the Arkansas Better Chance Program for the 2024-2025 school 2 year. 3 (b) It is the intent of the General Assembly to ensure a greater 4 opportunity for a more efficient utilization of current slots and resources 5 available in both the Arkansas Better Chance Program and Arkansas Better 6 Chance for School Success Program for Arkansas families and childcare 7 providers. 8 9 SECTION 2. Arkansas Code § 6-45-104(a)(2), concerning the requirement 10 of a local school to work with the Division of Elementary and Secondary 11 Education to develop an Arkansas Better Chance for School Success Program in 12 certain circumstances, is amended to read as follows: 13 (2) A local school is required to work with the Division of 14 Elementary and Secondary Education and its local community to establish, 15 promote, and assist in the development of a program under the Arkansas Better 16 Chance for School Success Program to serve all children in the school as 17 provided in  $\S 6-45-108$  § 6-45-105, if the school is located in a school 18 district classified as in need of Level 5 - Intensive support. 19 20 SECTION 3. Arkansas Code § 6-45-105 is amended to read as follows: 21 6-45-105. Establishment of Arkansas Better Chance Program - Arkansas 22 Better Chance for School Success Program. 23 (a)(1)(A) The Division of Elementary and Secondary Education shall 24 establish the Arkansas Better Chance Program to assist in the establishment 25 and funding of the appropriate early childhood programs for children from 26 birth through five (5) years of age. 27 (B) Within the Arkansas Better Chance Program there is 28 established the Arkansas Better Chance for School Success Program for 29 providing appropriate early care and education programs for children three (3) years of age and four (4) years of age as identified under § 6-45-108(a) 30 31 from birth through five (5) years of age. 32 (C) The Division of Elementary and Secondary Education 33 shall establish the same criteria and qualifications for eligibility to 34 participate in the Arkansas Better Chance Program and the Arkansas Better 35 Chance for School Success Program.

(D) A child from birth through five (5) years of age who

- 1 meets at least one (1) of the qualifications established by the Division of
- 2 Elementary and Secondary Education for the Arkansas Better Chance Program or
- 3 the Arkansas Better Chance for School Success Program shall be eligible to
- 4 participate in the Arkansas Better Chance Program or the Arkansas Better
- 5 Chance for School Success Program.
- 6 (2)(A) The Division of Elementary and Secondary Education shall
- 7 award grants or contracts to appropriate early childhood programs
- 8 selected by the Division of Elementary and Secondary Education in accordance
- 9 with specified programmatic standards.
- 10 (B)(i) These standards  $\frac{\text{will}}{\text{shall}}$  be developed by the
- 11 Division of Elementary and Secondary Education, with the advice and
- 12 assistance of the Arkansas Early Childhood Commission.
- 13 (ii) Standards for funding the Home Instruction for
- 14 Parents of Preschool Youngsters (HIPPY) U.S.A.  $\frac{11}{2}$  be developed in
- 15 conjunction with the Arkansas HIPPY Advisory Board.
- 16 (C) The Home Instruction for Parents of Preschool
- 17 Youngsters (HIPPY) U.S.A. regional technical assistance and training center
- 18 shall be defined and funded as an integral part of the Home Instruction for
- 19 Parents of Preschool Youngsters (HIPPY) U.S.A. to provide necessary training,
- 20 technical assistance, and program support to program sites in Arkansas.
- 21 (b) The programmatic standards and other rules necessary for the
- 22  $\,$  implementation of the Arkansas Better Chance Program  $\underline{and}$  the Arkansas Better
- 23 Chance for School Success Program shall be adopted by the State Board of
- 24 Education in accordance with the provisions of the Arkansas Administrative
- 25 Procedure Act, § 25-15-201 et seq.
- 26 (c)(1) The Division of Elementary and Secondary Education may expend a
- 27 maximum of two percent (2%) of available funds to administer the Arkansas
- 28 Better Chance Program and the Arkansas Better Chance for School Success
- 29 <u>Program</u> and to monitor Arkansas Better Chance Program <u>and Arkansas Better</u>
- 30 Chance for School Success Program grantees to ensure compliance with
- 31 programmatic standards.
- 32 (2) The Division of Elementary and Secondary Education may
- 33 contract with the Division of Child Care and Early Childhood Education to
- 34 administer the Arkansas Better Chance Program and the Arkansas Better Chance
- 35 for School Success Program.

Ţ	SECTION 4. Arkansas Code § 6-45-108 is repealed.
2	6-45-108. Criteria for determining need.
3	(a)(1) All children three (3) years of age and four (4) years of age
4	who are members of a family with a gross family income not exceeding two
5	hundred percent (200%) of the federal poverty guidelines are eligible to
6	attend an Arkansas Better Chance for School Success Program if there is an
7	Arkansas Better Chance for School Success Program available in the school
8	district where the child resides and if there is available space for the
9	child to attend the Arkansas Better Chance for School Success Program.
10	(2) The Division of Elementary and Secondary Education and the
11	Division of Child Care and Early Childhood Education may develop a fee
12	schedule and establish eligibility based on family income for children who
13	are not eligible under subdivision (a)(1) of this section, but priority
14	enrollment shall be allowed to children eligible under subdivision (a)(1) of
15	this section.
16	(b) The Division of Elementary and Secondary Education and the
17	Division of Child Care and Early Childhood Education shall review various
18	criteria for identifying and targeting the areas of the state with the
19	greatest need for early childhood programs.
20	(c) The State Board of Education, with the advice and assistance of
21	the Division of Child Care and Early Childhood Education, shall adopt the
22	appropriate criteria for identifying Arkansas children with the greatest need
23	to participate in Arkansas Better Chance for School Success Program-funded
24	early childhood programs.
