19	(c) The fund shall be used exclusively for the purpose of erecting and		
20	maintaining a suitable monument on the State Capitol grounds in recognition

33	Capitol Building	in pr	oximity to the existing bust of Winthrop Rockefeller.

35	similar to the ex	istin	g busts located in the State Capitol Building.
