Subtitle TO CREATE THE ARKANSAS 2036 COMMISSION. BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS: SECTION 1. DO NOT CODIFY. TEMPORARY LANGUAGE. Arkansas 2036 Commission — Creation — Purpose — Members. (a) There is created the Arkansas 2036 Commission. (b) The purpose of the commission is to: (1) Promote a suitable statewide observance of the two hundred birthday of Arkansas: (2) Explore the possible construction of a commemorative landma that promotes tourism to the state; (3) Cooperate and assist the Division of Arkansas Heritage with programs commemorating the two hundredth birthday of the state; and (4) Provide assistance for the development of programs. projects, and activities promoting the history and heritage of the state. (c) The commission shall consist of eight (8) members to include: (1) The Director of the Division of Arkansas Heritage or his of her designee: (2) The Secretary of the Department of Education or his or her designee: (3) Two (2) members appointed by the Speaker of the House of

1	(4) Two (2) members appointed by the President Pro Tempore of
2	the Senate; and
3	(5) Two (2) members appointed by the Governor.
4	(d)(1) The director or his or her designee shall serve as the chair of
5	the commission.
6	(2) The director or his or her designee shall call the first
