32	BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL
33	ASSEMBLY OF THE STATE OF ARKANSAS, THE SENATE CONCURRING THEREIN:

35	(a) That the Regular Session of the Ninety-Fifth General Assembly of
36	the State of Arkansas is extended until 12:00 noon, May 5, 2025;



1 That under Arkansas Constitution, Article 6, § 15, prior to (b) 2 adjournment of the General Assembly, the Governor is afforded five (5) days after receipt of a bill to sign a bill or veto a bill, therefore from April 3 4 16, 2025, to May 5, 2025, the House of Representatives and the Senate shall 5 be open so the office of the Chief Clerk of the House of Representatives and 6 the office of the Secretary of the Senate may receive communications, vetoes 7 of bills by the Governor, and notification of errors and oversights; 8 That the Regular Session of the Ninety-Fifth General Assembly of (c) 9 the State of Arkansas shall enter into recess simultaneously at the close of 10 business in each chamber on April 16, 2025, or at such earlier time as may be agreed upon by the House of Representatives and the Senate; 11 12 (d) That the Speaker of the House of Representatives and the President Pro Tempore of the Senate may, by joint proclamation: 13 14 Reconvene the General Assembly at any time before 12:00 (1)15 noon, May 5, 2025, for the purpose of: 16 (A) Considering vetoes; 17 (B) Correcting errors and oversights; 18 (C) Completing its work on proposed constitutional 19 amendments; and 20 (D) Considering the need for further extension of the 21 Regular Session of the Ninety-Fifth General Assembly; or 22 (2) Adjourn the Regular Session of the Ninety-Fifth General 23 Assembly at any time before 12:00 noon, May 5, 2025, if they determine it is 24 not necessary to reconvene; and 25 That if the General Assembly is not reconvened or adjourned (e) 26 before 12:00 noon, May 5, 2025, the Regular Session of the Ninety-Fifth 27 General Assembly is adjourned sine die on that date. 28 29 30 31 32 33 34 35 36
