WHEREAS, the City of Bentonville, Arkansas, and Visit Bentonville have
demonstrated a steadfast commitment to cycling through strategic investments
in trails, infrastructure, marketing, and community engagement; and

destination for mountain biking, proclaimed in the title of Mountain Biking
