| 35 | THAT the following is proposed as an amendment to the Constitution of |

1 for approval or rejection at the next general election for Representatives 2 and Senators, if a majority of the electors voting thereon at the election 3 adopt the amendment, the amendment shall become a part of the Constitution of 4 the State of Arkansas, to wit: 5 6 SECTION 1. Arkansas Constitution, Article 19, § 31(b), concerning the 7 independent citizens commission existing for the purpose of setting salaries 8 of elected constitutional officers of the executive department, members of 9 the General Assembly, justices, judges, and prosecuting attorneys, is amended 10 to add an additional subdivision to read as follows: 11 (9) By a vote of at least two-thirds (2/3) of the membership of 12 the Senate, the Senate may remove a member of the independent citizens commission before the expiration of his or her term for cause only, after 13 14 notice and hearing. 15 SECTION 2. Arkansas Constitution, Amendment 33, § 4, is amended to 16 17 read as follows: 18 § 4. Removal of member - Procedure - Appeal. 19 The Governor shall have the power to remove any member of such boards 20 or commissions before the expiration of his term for cause only, after notice 21 and hearing. Such removal shall become effective only when approved in 22 writing by a majority of the total number of the board or commission, but 23 without the right to vote by the member removed or by his successor, which action shall be filed with the Secretary of State together with a complete 24 25 record of the proceedings at the hearing. 26 An appeal may be taken to the Pulaski Circuit Court by the Governor or 27 the member ordered removed, and the same shall be tried de novo on the record. An appeal may be taken from the circuit court to the Arkansas Supreme 28 29 Court, which shall likewise be tried de novo. 30 By a vote of at least two-thirds (2/3) of the membership of the Senate, the Senate may remove a member of a board or commission under this amendment 31 32 before the expiration of his or her term for cause only, after notice and 33 hearing. 34 SECTION 3. Arkansas Constitution, Amendment 35, § 5, is amended to 35 36 read as follows:

| 18 | the Medical Marijuana Commission, is amended to read as follows: |
| 19 | (7) By a vote of at least two-thirds $(2/3)$ of the membership of |
| 20 | the Senate, the Senate may remove a member of the commission before the |
| 21 | expiration of his or her term for cause only, after notice and hearing. |

| 23 | SECTION 6. Arkansas Constitution, Article 5, is amended to add an |
| 24 | additional section to read as follows: |
| 25 | § 43. Removal of members of boards and commissions. |
| 26 | (a) By a vote of at least two-thirds (2/3) of the membership of the |
| 27 | Senate, the Senate may remove a member of a board or commission established |
| 28 | under this Constitution or Arkansas law before the expiration of his or her |
| 29 | term for cause only, after notice and hearing. |
| 30 | (b) The method for removal of a member of a board or commission under |
| 31 | subsection (a) of this section shall be supplemental to other methods of |
| 32 | removal provided for by this Constitution or Arkansas law. |

| 34 | SECTION 7. EFFECTIVE DATE. <u>This amendment to the Arkansas</u> |
