20	WHEREAS, St. Bernards Healthcare serves Northeast Arkansas and
21	Southeast Missouri with cancer care, heart and vascular care, primary care,
22	emergency services, senior services, women's and children's services,
23	surgical services, and virtual care; and
24	
25	WHEREAS, St. Bernards Healthcare was founded as an independent,
26	nonprofit, Catholic healthcare system and works to uphold its mission "To
27	provide Christ-like healing to the community"; and
28	
29	WHEREAS, St. Bernards Medical Center in Jonesboro opened as a six-room
30	hospital in 1900 and now serves as the largest bed-referral center in East
31	Arkansas and Southeast Missouri; and
32	
33	WHEREAS, in 2016, the St. Bernards Pregnancy Clinic opened to provide
34 25	prenatal services to combat adverse maternal outcomes in eastern Arkansas;

1	WHEREAS, the St. Bernards Pregnancy Clinic's mission is "to provide
2	vital prenatal and postpartum care to all women, regardless of insurance
3	status or health history"; and
4	
5	WHEREAS, in November 2024, St. Bernards Medical Center in Jonesboro
6	partnered with the Department of Human Services to open the first Maternal
7	Life360 HOME in the state to serve women with high-risk pregnancies; and
8	
9	WHEREAS, the Maternal Life360 HOME program supports women with high-
10	risk pregnancies who are enrolled in the Arkansas Health and Opportunity for
11	Me Program and traditional Medicaid through home-visit services during
12	pregnancy and for up to two (2) years postpartum; and
13	
14	WHEREAS, the program functions not only to improve challenging maternal
15	outcomes but also to address related social needs like food security and
16	housing to benefit the long-term health and well-being of women and children,
17	
18	NOW THEREFORE,
19	BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL
20	ASSEMBLY OF THE STATE OF ARKANSAS:
21	
22	THAT the House of Representatives honor St. Bernards Medical Center in
23	Jonesboro for being the first medical facility in the state to open a
24	Maternal Life360 HOME.
