9 TO RECOGNIZE AND CELEBRATE ARKANSAS FORESTRY DAY AT
10 THE STATE CAPITOL ON JANUARY 21, 2025.

14 TO RECOGNIZE AND CELEBRATE ARKANSAS
15 FORESTRY DAY AT THE STATE CAPITOL ON
16 JANUARY 21, 2025.

18 WHEREAS, private landowners own fifteen million three hundred thousand
19 (15,300,000) acres of the state's forests and three million six hundred
20 thousand (3,600,000) acres are publicly owned by federal, state, and other
21 public entities; and
22

23 WHEREAS, forests provide more than five thousand (5,000) products we
24 depend on every day; and
25

26 WHEREAS, the state's abundant forest resources have provided important
27 economic and environmental benefits to the state and nation since the 1880s;
28 and
29

30 WHEREAS, the state's forested lands are diverse in their makeup with
31 six million two hundred thousand (6,200,000) acres of softwoods, one million
32 nine hundred thousand (1,900,000) acres of oak and pine, and ten million four
33 hundred thousand (10,400,000) acres of hardwoods; and

35 WHEREAS, forestry's value-added contribution to the state's economy is
36 seven billion dollars (\$7,000,000,000); and

2 WHEREAS, the forest products industry supports twenty-six thousand nine
3 hundred eighty (26,980) direct jobs and fifty-four thousand seven hundred
4 fifty-nine (54,759) total jobs; and

5
6 WHEREAS, one (1) in fourteen (14) Arkansans owns forestland; and

7
8 WHEREAS, sixty-seven percent (67%) of the state's forests are owned by
9 family forest landowners; and

10
11 WHEREAS, Arkansas families depend on the one billion eight hundred
12 fifty million dollars (\$1,850,000,000) in direct wages provided by the forest
13 products industry; and

14
15 WHEREAS, the average compensation in the forest products industry is
16 higher than both the national and Arkansas average wage; and

17
18 WHEREAS, for every one (1) job created by the forestry industry in the
19 State of Arkansas, two and four-tenths (2.4) jobs are created indirectly; and

20
21 WHEREAS, timber harvesters and forest landowners follow voluntary best
22 management practices that protect water quality; and

23
24 WHEREAS, the state's forests provide unparalleled scenic beauty; and

25
26 WHEREAS, forests in Arkansas support habitat for more than six hundred
27 (600) species of fish and wildlife; and

28
29 WHEREAS, the state's forest landowners manage their land to protect and
30 enhance habitat for threatened and endangered species;

31
32 WHEREAS, since 1947 the Arkansas Forestry Association has served as the
33 voice of forestry for the state's entire forestry community,

35 NOW THEREFORE,

36 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL

1 ASSEMBLY OF THE STATE OF ARKANSAS:

3 THAT the House of Representatives recognize and celebrate Arkansas
4 Forestry Day at the State Capitol Building on January 21, 2025.
