WHEREAS, Dr. Brendan Kelly began his tenure as the third President of
the Arkansas State University system on September 23, 2024; and
WHEREAS, the Arkansas State University System is based in Little Rock
and serves more than thirty-five thousand (35,000) students annually on
campuses in Arkansas and Mexico, and globally online; and
WHEREAS, Dr. Brendan Kelly served as president of the University of
West Georgia for four years before becoming President of the Arkansas State
University system; and
WHEREAS, Dr. Brendan Kelly's focus at the University of West Georgia
was innovative programming both inside and outside the classroom with an
emphasis on creating valuable life and career outcomes for students, with a
commitment to launch and advance student careers upon graduation; and
WHEREAS, while serving at the University of West Georgia, Dr. Brendan
Kelly served on the board of directors of multiple regional and state
economic development entities as well as the Atlanta Regional Higher



2 3 WHEREAS, while leading and implementing the "Becoming UWG" institutional strategic plan at the University of West Georgia, Dr. Brendan 4 5 Kelly led the university to recordbreaking fundraising efforts, including the 6 largest gift in institutional history, and oversaw an enrollment resurgence; 7 and 8 9 WHEREAS, Dr. Brendan Kelly also served in the past as Chancellor of the University of South Carolina Upstate, was appointed Interim President of the 10 University of South Carolina, and was Vice President of University 11 12 Advancement and President of the UWF Foundation, Inc., at the University of 13 West Florida; and 14 15 WHEREAS, Dr. Brendan Kelly also taught communication arts for thirteen 16 (13) years in Michigan and Florida; and 17 18 WHEREAS, Dr. Brendan Kelly is a member of the Board of Directors of the 19 American Association of State Colleges and Universities and was named one of 20 the Most Influential Georgians by Georgia Trend Magazine and James Magazine 21 Online; and 22 23 WHEREAS, Dr. Brendan Kelly was active with the National Forensic 24 Association and speech and debate competition for many years, and was honored 25 as a National Forensic Association Hall of Fame inductee and also with the 26 National Forensic Association Eddie Myers Distinguished Service Award; and 27 28 WHEREAS, Dr. Brendan Kelly received a Bachelor of Science in Public 29 Relations and a Master of Arts in Communications at Eastern Michigan 30 University, and a Doctor of Philosophy in Rhetoric and Political 31 Communication at Wayne State University; and 32 33 WHEREAS, Arkansas State University system trustee Price Gardner, who chaired the search on behalf of the Board of Trustees of the Arkansas State 34 35 University system, said of Dr. Brendan Kelly, "He has been described as a visionary, [a] talented communicator, and a person with the ability to 36
