24	the Smart Core continue to perform better on the ACT Assessment than students
25	who take less than the recommended core.

27	include:
28	(1) Four (4) years or more of English;
29	(2) Three (3) years or more of mathematics;
30	(3) Three (3) years or more of social studies; and
31	(4) Three (3) years or more of natural sciences.
