Application requirements. 23 (a) To request a matching grant under this subchapter, an applicant 24 shall complete and submit the application forms prescribed by the Division of 25 Science and Technology of the Arkansas Economic Development Commission under § 15-3-704. 26 27 (b) An applicant shall submit an application for each federal Phase I 28 and federal Phase II grant proposal for which the applicant is requesting a 29 matching grant. 30 (c) The division commission shall: 31 (1) Review applications: 32 (A) In order of receipt, as determined by the date and 33 time stamp of receipt; and 34 In accordance with rules promulgated by the division (B) 35 commission under § 15-3-709; and 36 (2) Not consider an incomplete or noncompliant application and

1 shall return an incomplete or a noncompliant application without further 2 review<del>:</del> 3 (3) Review each application with the advice and recommendation 4 of the Commercialization Committee of the Board of Directors of the Division 5 of Science and Technology of the Arkansas Economic Development Commission; 6 and 7 (4) Provide advice to the Director of the Arkansas Economic 8 Development Commission concerning the applications for matching grants 9 reviewed by the division. 10 (d)(1) Applications submitted to the division commission are subject to the Freedom of Information Act of 1967, § 25-19-101 et seq. 11 12 (2) To the extent an applicant believes that information in an 13 application is confidential or otherwise exempt under the Freedom of 14 Information Act of 1967, § 25-19-101 et seq., the applicant shall 15 specifically designate in writing the information the applicant believes to 16 be confidential or exempt and the basis for the confidentiality or exemption 17 on that portion of the application in which the information appears. 18 15-3-707. Matching grant awards. 19 20 (a) A matching grant awarded under this subchapter: 21 (1) Shall not: 22 (A) Be awarded under this subchapter unless offered in 23 writing by the Director of the Arkansas Economic Development Commission; and 24 Exceed fifty percent (50%) of the federal Small (B) 25 Business Innovation Research award or the Small Business Technology Transfer 26 award, up to: 27 Fifty thousand dollars (\$50,000) for a matching (i) 28 grant awarded to match a federal Phase I award; and (ii) One hundred thousand dollars (\$100,000) for a 29 30 matching grant awarded to match a federal Phase II award; and 31 (2) Subject to funding and the discretion of the director, may 32 be offered to an eligible applicant that successfully completes the 33 application process. 34 The matching grant agreement between the Division of Science and (b) 35 Technology of the Arkansas Economic Development Commission and the eligible applicant shall delineate all requirements of the matching grant. 36

2	matching grant shall be spent in Arkansas.

4	basis, payable when invoices and financial reports are submitted to <u>and</u>
