Further, the General Assembly has determined that the 18 Department of Human Services may operate more efficiently if some flexibility 19 is provided to the Department of Human Services authorizing broad powers 20 under this Section. Therefore, it is both necessary and appropriate that the 21 General Assembly maintain oversight by requiring prior approval of the 22 Legislative Council or Joint Budget Committee as provided by this section. 23 The requirement of approval by the Legislative Council or Joint Budget 24 Committee is not a severable part of this section. If the requirement of 25 approval by the Legislative Council or Joint Budget Committee is ruled 26 unconstitutional by a court of competent jurisdiction, this entire section is 27 void.
