35	<u>(B</u>) "Administrative services" includes witho	out limitation:
36		(i) Assistance with a claim;	



1	(ii) Assistance with an audit;
2	(iii) Assistance with access to a pharmacy network;
3	(iv) Assistance with interactions between a pharmacy
4	and a pharmacy benefits manager;
5	(v) Centralized payment;
6	(vi) Certification in a specialized care program;
7	(vii) Compliance support;
8	(viii) Setting a flat fee for generic drugs;
9	(ix) Assistance with store layout;
10	(x) Marketing support;
11	(xi) Management and analysis of payment and drug
12	dispensing data; or
13	(xii) Provision of resources for a retail cash card;
14	(2) "Pharmacy benefits manager" means a person or an entity
15	operating within this state that contracts with a health benefit plan, an
16	employer, or a union to administer or manage prescription drug benefits on
17	behalf of a healthcare insurer that provides prescription drug benefits;
18	(3)(A) "Pharmacy services administrative organization" means an
19	entity operating within this state that contracts with one (1) or more
20	independent pharmacies to conduct business on their behalf with a third-party
21	payer.
22	(B) "Pharmacy services administrative organization"
23	includes a person or entity that performs one (1) or more administrative
24	services on behalf of one (1) or more pharmacies and negotiates and enters a
25	contract with a third-party payer or pharmacy benefits manager on behalf of a
26	pharmacy;
27	(4) "Pharmacy services administrative organization-pharmacy
28	contract" means a contractual agreement between a pharmacy services
29	administrative organization and an independent pharmacy by which a pharmacy
30	services administrative organization agrees to negotiate with a third-party
31	payer on behalf of an independent pharmacy and to provide other services as
32	stated in the pharmacy services administrative organization-pharmacy
33	contract; and
34	(5)(A) "Third-party payer" means an organization operating
35	within this state that pays or insures health, medical, or prescription drug
36	expenses on behalf of beneficiaries.

1	(B) "Third-party payer" includes a:
2	(i) Plan sponsor;
3	(ii) Healthcare service plan;
4	(iii) Health maintenance organization; or
5	(iv) Healthcare insurer.
6	(C) "Third-party payer" does not include a nonfederal
7	governmental plan as defined in 29 U.S.C. § 1002(32), as it existed on
8	January 1, 2025.
9	
10	23-99-1903. Registration required.
11	(a)(l) A person or organization shall not establish or operate as a
12	pharmacy services administrative organization in Arkansas for health benefit
13	plans without obtaining a license from the Insurance Commissioner under this
14	subchapter.
15	(2) The commissioner shall prescribe the application for a
16	license to operate in Arkansas as a pharmacy services administrative
17	organization and may charge application fees and renewal fees as established
18	by rule.
19	(b) The commissioner shall issue rules establishing the licensing,
20	fees, application, financial standards, penalties, compliance and enforcement
21	requirements, and reporting requirements of a pharmacy services
22	administrative organization under this subchapter.
23	(c) This subchapter does not require a third-party payer to enter a
24	contract with a pharmacy services administrative organization.
25	
26	23-99-1904. Notice and disclosure requirements.
27	(a) A pharmacy services administrative organization-pharmacy contract
28	shall include a provision that requires a pharmacy services administrative
29	organization to provide to an independent pharmacy a copy of the pharmacy
30	services administrative organization-pharmacy contract, amendment, payment
31	schedule, or reimbursement rates within three (3) calendar days after the
32	execution of a pharmacy services administrative organization-pharmacy
33	contract, or an amendment to a pharmacy services administrative organization-
34	pharmacy contract, signed on behalf of the independent pharmacy.
35	
55	(b) A pharmacy services administrative organization shall disclose to

1	pharmacy services administrative organization by a parent company,
2	subsidiary, or other organization that:
3	(1) Provides pharmacy services or support;
4	(2) Provides prescription drug or device services; or
5	(3) Manufactures, sells, or distributes prescription drugs,
6	biologicals, or medical devices.
7	(c) A pharmacy services administrative organization shall notify the
8	department in writing within five (5) calendar days of any material change in
9	its ownership or control relating to any company, subsidiary, or other
10	organization described in subsection (b) of this section.
11	(d)(l) Before entering into a pharmacy services administrative
12	organization-pharmacy contract, a pharmacy services administrative
13	organization shall disclose to an independent pharmacy a written disclosure
14	of ownership or control in order to assist the independent pharmacy in making
15	an informed decision regarding its relationship with the pharmacy services
16	administrative organization.
17	(2) The disclosure required under subdivision (d)(1) of this
18	section shall include the extent of any ownership or control by a parent
19	company, subsidiary, or other organization that:
20	(A) Provides pharmacy services or support;
21	(B) Provides prescription drug or device services; or
22	(C) Manufactures, sells, or distributes prescription
23	drugs, biologicals, or medical devices.
24	(e) A pharmacy services administrative organization-pharmacy contract
25	shall provide that the pharmacy services administrative organization shall
26	notify the independent pharmacy in writing within five (5) calendar days of
27	any material change in its ownership or control related to any company,
28	subsidiary, or other organization described in subdivision (d)(l) of this
29	section.
30	(f)(1) Before entering into a contract with a third-party payer, a
31	pharmacy services administrative organization shall furnish to a pharmacy
32	benefits manager or a third-party payer a written disclosure of ownership or
33	control in order to assist the pharmacy benefits manager or the third-party
34	payer in making an informed decision regarding the pharmacy benefits
35	manager's or the third-party payer's relationship with the pharmacy services
36	administrative organization and the independent pharmacy or pharmacies for

1	which the pharmacy services administrative organization is negotiating.
2	(2) The disclosure required under subdivision (f)(1) of this
3	section shall include the extent of any ownership or control by any parent
4	company, subsidiary, or other organization that:
5	(A) Provides pharmacy services or support;
6	(B) Provides prescription drug or device services; or
7	(C) Manufactures, sells, or distributes prescription
8	drugs, biologicals, or medical devices.
9	(g) A pharmacy services administrative organization-pharmacy contract
10	with a third-party payer shall require that a pharmacy services
11	administrative organization shall notify the third-party payer in writing
12	within five (5) calendar days of any material change in its ownership or
13	control related to any company, subsidiary, or other organization described
14	in subdivision (f)(l) of this section.
15	
16	23-99-1905. Accounting — Audits — Timely transmission of remittance —
17	Reporting patient cost sharing assistance.
18	(a) A contract between a pharmacy benefits manager and a pharmacy
19	services administrative organization under which the pharmacy benefits
20	manager has the right or obligation to conduct an audit of an independent
21	pharmacy shall contain specific language that permits the pharmacy benefits
22	manager to obtain information from the pharmacy services administrative
23	organization in connection with the pharmacy benefits manager's audit of an
24	independent pharmacy.
25	(b) A pharmacy services administrative organization-pharmacy contract
26	shall provide that a remittance for a claim submitted by a pharmacy benefits
27	manager or third-party payer on behalf of a pharmacy to the pharmacy services
28	administrative organization shall be passed through by the pharmacy services
29	administrative organization to the independent pharmacy within a reasonable
30	amount of time, established in the pharmacy services administrative
31	organization-pharmacy contract, after receipt of the remittance by the
32	pharmacy services administrative organization from a pharmacy benefits
33	manager or third-party payer.
34	(c)(l) A pharmacy services administrative organization that provides,
35	accepts, or processes a discount, concession, or product voucher to reduce,
36	directly or indirectly, a covered person's out-of-pocket expense for the

1	order, dispensing, substitution, sale, or purchase of a prescription drug
2	shall provide to the State Insurance Department an annual report, available
3	for public audit.
4	(2) The annual report required under subdivision (c)(1) of this
5	section shall include an aggregate total of:
6	(A) All transactions by the independent pharmacy; and
7	(B) Any payments received by a pharmacy services
8	administrative organization itself for providing, processing, or accepting a
9	discount, concession, or product voucher on behalf of an independent
10	pharmacy.
11	
12	23-99-1906. Wholesale and pharmacy services administrative
13	organization services - Single pharmacy services administrative organization-
14	pharmacy contract.
15	(a) A pharmacy services administrative organization that owns or is
16	owned by, in whole or in part, an entity that manufactures, sells, or
17	distributes prescription drugs, biologicals, or medical devices, as a
18	condition of entering into a pharmacy services administrative organization-
19	pharmacy contract, shall not require that the independent pharmacy purchase
20	any drugs or medical devices solely from the entity with which the pharmacy
21	services administrative organization has an ownership interest or from an
22	entity with an ownership interest in the pharmacy services administrative
23	organization.
24	(b) A pharmacy services administrative organization that owns or is
25	owned by, in whole or in part, an entity that manufactures, sells, or
26	distributes prescription drugs, biologicals, or medical devices shall
27	disclose to the State Insurance Department any agreement with an independent
28	pharmacy in which the independent pharmacy purchases prescription drugs,
29	biologicals, or medical devices from a pharmacy services administrative
30	organization or from an entity that owns or is owned by, in whole or in part,
31	the pharmacy services administrative organization.
32	
33	23-99-1907. Notice of appeals.
34	(a) A pharmacy services administrative organization-pharmacy contract
35	shall provide that if there is a dispute between an independent pharmacy and
36	a pharmacy benefits manager or a third-party payer, the pharmacy services

1	administrative organization shall ensure and facilitate timely communication
2	from the independent pharmacy to the pharmacy benefits manager or the third-
3	party payer.
4	(b) A pharmacy services administrative organization-pharmacy contract
5	shall provide that the pharmacy services administrative organization shall
6	forward a notice of appeal from an independent pharmacy to the pharmacy
7	benefits manager or the third-party payer in a timely manner.
8	(c) If an appeal does not meet the minimum requirements described in
9	the pharmacy services administrative organization-pharmacy contract, the
10	pharmacy services administrative organization shall:
11	(1) Provide the pharmacy with the reason for the denial of the
12	appeal; and
13	(2) Allow the pharmacy to resubmit the appeal for a review by a
14	pharmacy benefits manager.
15	(d) In connection with an appeal or similar process under § 17-92-507,
16	a third-party payer's or pharmacy benefits manager's notice or provision of
17	information to a pharmacy services administrative organization is deemed to
18	be notice or provision of information to the pharmacy on whose behalf the
19	pharmacy services administrative organization has contracted.
20	
21	<u>23-99-1908. Enforcement.</u>
22	(a) The Insurance Commissioner shall enforce this subchapter.
23	(b)(1) The commissioner may examine or audit the books and records of
24	a pharmacy services administrative organization providing claims
25	administrative services for a pharmacy to determine if the pharmacy services
26	administrative organization is in compliance with this subchapter.
27	(2) The information or data acquired during an examination under
28	subdivision (b)(1) of this section is:
29	(A) Considered proprietary and confidential under §§ 23-
30	<u>61-107(a)(4)</u> and 23-61-207; and
31	(B) Not subject to the Freedom of Information Act of 1967,
32	<u>§ 25-19-101 et seq.</u>
33	(c) After notice and opportunity for hearing, the commissioner may:
34	(1) Impose a civil penalty of up to five thousand dollars
35	(\$5,000) per violation against a pharmacy services administrative
36	organization if the commissioner finds that the pharmacy services

1	administrative organization has violated this subchapter; or
2	(2) Revoke or suspend the license of a pharmacy services
3	administrative organization.
