25	<u>14-234-123. Service to county property within the boundaries of a</u>	
26	municipality required.	
27	(a) A municipality that owns or operates a waterworks system shall	
28	provide services to any property owned by the county located within the	
29	boundaries of the municipality at the request of the county judge.	
30	(b) The county shall provide payment for:	
31	(1) Costs associated with the connection to the waterworks	
32	system operated by the municipality for the property owned by the county; an	<u>d</u>
33	(2) Services at the rates charged to other customers of the	
34	waterworks system.

36	SECTION 2. Arkansas Code Title 14, Chapter 235, Subchapter 2, is	



1	amended to add an additional section to read as follows:
2	14-235-227. Service to county property within the boundaries of a
3	municipality required.
4	(a) A municipality that owns or operates a sewage collection system or
5	a sewage treatment plant under this subchapter shall provide services to any
6	property owned by the county located within the boundaries of the
7	municipality at the request of the county judge.
8	(b) The county shall provide payment for:
9	(1) Costs associated with the connection to the sewage
10	collection system or sewage treatment plant operated by the municipality for
11	the property owned by the county; and
12	(2) Services at the rates charged to other customers of the
13	sewage collection system.
