10	(1) On or before January 1, 2026; or		
11	(2) If approval under § 10-3-309 has not occurred by January 1,		
12	2026, as soon as practicable after approval under § 10-3-309.		
13	(b) The department shall file the proposed rules with the Legislative		
14	Council under § 10-3-309(c) sufficiently in advance of January 1, 2026, so		
15	that the Legislative Council may consider the rules for approval before		
16	January 1, 2026.
