13	SECTION 4. EMERGENCY CLAUSE. It is found and determined by the		
14	General Assembly of the State of Arkansas that the General Assembly passed		
15	Acts 2025, No. 373, to allow for significant investment in electric public		
16	utility infrastructure and natural gas public utility infrastructure to		
17	enable this state to attract and serve economic development projects across		
18	variety of industries, as well as to continue reliably supporting existing		
19	and new customers; that an engrossing error was discovered during the review		
20	of Acts 2025, No. 373; and that this act is immediately necessary to correct		
21	the engrossing error found during the review of Acts 2025, No. 373.		
22	Therefore, an emergency is declared to exist, and this act being immediately		
23	necessary for the preservation of the public peace, health, and safety shall		
24	become effective on:		
25	(1) The date of its approval by the Governor;		
26	(2) If the bill is neither approved nor vetoed by the Governor,		
27	the expiration of the period of time during which the Governor may veto the		
28	bill; or		
29	(3) If the bill is vetoed by the Governor and the veto is		
30	overridden, the date the last house overrides the veto.
