27	and other chronic conditions	, and recover from or prevent ir	ijury and chronic
28	disease;		
29	(2) However, th	e program reimburses for physica	<u>l therapy only in</u>
30	<u>a hospital-based setting;</u>		
31	(3) Research ha	s found that access to rehabilit	ative physical
32	therapy in clinic-based sett	ings leads to lower total costs	of care over
33	time, decreases the need for	surgical interventions, and red	luces the need for
34	long-term use of opioids and	other pain medications; and	
35	<u>(4) Expanding c</u>	overage for rehabilitative physi	<u>cal therapy in</u>
36	clinic-based settings under	the program would result in cost	<u>savings to the</u>
