17	WHEREAS, child abuse and neglect is a serious problem affecting every
18	segment of Arkansas communities, and finding solutions requires action from
19	everyone in our communities; and
20	
21	WHEREAS, our children are our most valuable resource and will shape the
22	future of our state; and
23	
24	WHEREAS, child abuse can have long-term psychological, emotional, and
25	physical effects that can have lifelong consequences for victims of abuse;
26	and
27	
28	WHEREAS, protective factors are conditions that reduce or eliminate
29	risk and promote the social, emotional, and developmental well-being of
30	children; and
31	
32	WHEREAS, effective child abuse prevention activities succeed because of
33	the meaningful connections and partnerships created between child welfare,
34	education, health, community and faith-based organizations, businesses, and
35	law enforcement agencies; and

1 WHEREAS, prevention of child abuse and maltreatment remains Arkansas's 2 goal for our children and families; and 3 4 WHEREAS, communities are encouraged to promote programs and activities 5 that benefit children and their families; and 6 7 WHEREAS, it is important to work together to increase awareness about 8 child abuse and support the social and emotional well-being of children and 9 families in a safe, stable, and nurturing environment; and 10 11 WHEREAS, child advocacy centers were formed to provide a safe, child-12 friendly environment where a comprehensive and coordinated approach is taken 13 to allegations of child abuse; and 14 15 WHEREAS, the specially trained individuals who staff child advocacy 16 centers assist and advocate for the child throughout the entire process; and 17 18 WHEREAS, during the process, the child advocacy center staff works as 19 part of a multi-disciplinary team that includes the Crimes Against Children 20 Division of the Division of Arkansas State Police, the Division of Children 21 and Family Services of the Department of Human Services, local law 22 enforcement agencies, prosecutors, mental health professionals, and other 23 state and local agencies, 24 25 NOW THEREFORE, 26 BE IT RESOLVED BY THE SENATE OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE 27 STATE OF ARKANSAS: 28 29 THAT the Senate recognize April as Child Abuse and Neglect Prevention 30 Month, and encourage citizens, community agencies, faith-based organizations, 31 medical facilities, and businesses to increase their participation in 32 supporting families, thereby preventing child abuse and strengthening 33 Arkansas communities. 34 35 36
