14 of the State shall seek prior review by the Arkansas Legislative Council or
15 Joint Budget Committee before the transfer shall be made.

16 The provisions of this section shall be in effect only from July 1, ~~2025~~
17 2026 through June 30, ~~2026~~ 2027.

18

19 SECTION 64. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
20 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. POSITION
21 ESTABLISHMENT. The Chief Fiscal Officer of the State shall have the authority
22 to establish such positions as necessary for State agencies to process
23 payroll through the Arkansas Administrative Statewide Information System for
24 federal and state tax reporting purposes as necessary to comply with the
25 United States Internal Revenue Code (IRC), 2001-Code-Vol, Sec 3401 and
26 Treasury Regulations §31.3401(c)-1(a) and §1.1402(c)-2(b), and others which
27 govern the reporting of income and payment of withholding and matching taxes
28 for personal services. The positions established shall not be considered as
29 part of the total number of authorized positions for an agency and shall only
30 be considered as placeholders for payments to individuals who are board or
31 commission members or elected officials of the State that do not otherwise
32 receive salaries or wages as defined in Arkansas Code § 19-4-512 for their
33 personal services. Further, none of the positions established under this
34 section shall imply eligibility for state retirement or state health
35 insurance benefits. The establishment of such positions shall not exceed 250
36 positions in any fiscal year.

6 AUTHORIZED - ARKANSAS CHILDREN'S HOSPITAL. The Arkansas Children's Hospital
7 may request the Chief Fiscal Officer of the State to transfer funds made
8 available for the following by this Act sums not to exceed \$1,000,000 for the
9 Arkansas Children's Hospital Burn Center, \$700,000 for the Children's
10 Hospital Payments, \$600,000 for the Reproductive Health Monitoring, and
11 \$233,600 for the Intensive Care Nursery each fiscal year from the
12 Miscellaneous Agencies Fund Account to the Department of Human Services
13 Grants Fund Account. The transferred funds shall be used to match federal
14 funds used for supplemental Medicaid payments to Arkansas Children's

27 INNOVATION AND PROJECT DEVELOPMENT FUND TRANSFERS. The Department of Shared
28 Administrative Services - Office of State Technology is a cost recovery
29 agency subject to the requirements of the United States Office of Management
30 and Budget Circular A-87 Cost Principles for State, Local and Indian Tribal
31 Government (A-87) and Cost Principles for Developing Cost Allocation Plans
32 and Indirect Cost Rates for Agreements with the Federal Government
33 Implementation Guide for the Office of Management and Budget Circular A-87
34 (ASMBC-10). To comply with these federal rules, it is necessary to establish
35 an Innovation and Project Development appropriation and general revenue fund
36 account within the Department of Finance and Administration - Disbursing

1 Officer for the Department of Shared Administrative Services - Office of
2 State Technology. This fund shall be used for state enterprise innovation
3 projects that would enhance the technology operations of the State that
4 cannot be cost allocated to federal programs. The Department of Shared
5 Administrative Services - Office of State Technology will maintain
6 documentation for projects billed for these purposes. Fund transfers may be
7 made from the General Revenue Fund Account, upon the approval of the Chief
8 Fiscal Officer of the State and prior review of the Arkansas Legislative
9 Council or Joint Budget Committee, to reimburse the Department of Shared
10 Administrative Services - Office of State Technology for the amounts billed.

16 PROCEDURES – PERSONAL SERVICES EXTRA HELP. In the event that there is not
17 sufficient appropriation provided for by the General Assembly for payment of
18 personal services related to Extra Help for any state agency for the period
19 ending June 30, ~~2026~~ 2027, said agency may request a transfer from
20 appropriations provided for Personal Services Extra Help in the Miscellaneous
21 Transfers Section herein, from the Chief Fiscal Officer of the State, stating
22 clearly the amount required. Upon approval of the Chief Fiscal Officer of
23 the State, and after seeking prior review by the Arkansas Legislative Council
24 or Joint Budget Committee, the State Auditor shall be notified as to the
25 amount and the purposes for which said appropriation is to be made. The
26 appropriation shall then be established upon the books of the Department of
27 Finance and Administration and the State Auditor. Provided further, that if
28 desired, said appropriation shall be supplemental to those regularly
29 appropriated for such purposes by the General Assembly for the agency.

35 INTRASTATE METRO PLANNING GRANTS. As referenced in Section 9 of Act 637 of
36 1995, the authorized funding for Intrastate Metro Planning Grants that are

2 Miscellaneous Grants and Expenses Section of this Act shall include the West
3 Central Arkansas Economic Development District.

4 The provisions of this section shall be in effect only from July 1, ~~2025~~
5 2026 through June 30, ~~2026~~ 2027.

6
7 SECTION 69. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
8 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUND
9 USAGE AUTHORIZED. The Arkansas Children's Hospital President and C.E.O. may
10 request the Department of Human Services-Division of Medical Services to
11 retain in the Department of Human Services Grant Fund account an amount not
12 to exceed \$1,000,000 for funds made available by the act to be used to match
13 federal funds used for supplemental Medicaid payments to Arkansas Children's
14 Hospital.

15 The provisions of this section shall be in effect only from July 1, ~~2025~~

18 SECTION 70. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
19 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER
20 PROCEDURES - MEDICAL MARIJUANA IMPLEMENTATION AND REGULATION. In the event
21 that sufficient appropriation is not provided by the General Assembly for
22 expenditures resulting from the implementation and regulation of the Arkansas
23 Medical Marijuana Amendment of 2016 for any state agency, pursuant to
24 Arkansas Code § 19-4-701 et seq., said agency shall request a transfer of
25 appropriation from the Chief Fiscal Officer of the State, stating clearly the
26 amount required. Upon approval of the Chief Fiscal Officer of the State said
27 appropriations shall be established upon the books of the Department of
28 Finance and Administration in compliance with the applicable classifications
29 of appropriations as enumerated in Arkansas Code §§ 19-4-511 through 19-4-
30 516.

31 The provisions of this section shall be in effect only from July 1, ~~2025~~
32 2026 through June 30, ~~2026~~ 2027.

33
34 SECTION 71. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
35 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUND
36 TRANSFER AUTHORITY. From time to time, the Chief Fiscal Officer of the State

1 may transfer from his or her books and those of the Treasurer of State and
2 the Auditor of State from the Medical Marijuana Implementation and Operations
3 Fund to various state agencies' funds the amounts necessary to fund the
4 expenses for the implementation, administration, and/or enforcement of the
5 Arkansas Medical Marijuana Amendment of 2016.

6 The provisions of this section shall be in effect only from July 1, ~~2025~~

11 BOND PROGRAM. The Secretary of the Department of Finance and Administration

13 Program appropriations authorized for State Employees (Appropriation 2DM),
14 County Employees (Appropriation 2DN), Municipal Employees (Appropriation 2DP)
15 and Public School Employees (Appropriation 2DQ).

16 The provisions of this section shall be in effect only from July 1, ~~2025~~
17 2026 through June 30, ~~2026~~ 2027.

19 SECTION 73. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
20 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER
21 PROCEDURES - VARIOUS TEMPORARY APPROPRIATION FOR STATE AGENCIES AND
22 INSTITUTIONS. (i) In the event that sufficient appropriation is not provided
23 by the General Assembly for any state agency or institution, an agency or
24 institution may request a transfer of appropriation, as provided in the
25 Various Temporary Appropriation for State Agencies and Institutions
26 Appropriation Section of this Act, from the Chief Fiscal Officer of the
27 State, stating clearly the amount requested, purpose and any additional
28 information requested by the Chief Fiscal Officer of the State.

29 (ii) After reviewing a request the Chief Fiscal Officer of the State may
30 deny, modify or approve the agencies or institutions request based on the
31 estimated amount of appropriation needed and currently available, purpose,
32 estimated funding available and preferred spending priority. Upon approval
33 or modification of a request by the Chief Fiscal Officer of the State and
34 after meeting the requirements of subsection (iii) herein, the Department of
35 Finance and Administration shall establish the transfer of appropriation on
36 the books of the Department of Finance and Administration and the State

1 Auditor, in compliance with the applicable classifications of appropriations

3 (iii) Any request approved as authorized in subsection (ii) herein,
4 including requests that establish a new commitment item or new appropriation

6 meeting in Regular or Fiscal Session the Joint Budget Committee.

7 (iv) Any appropriation approved as authorized in this Section shall not be
8 carried forward to the next fiscal year and shall be identified as a change
9 level increase by the state agency or institution, if requested.

10 (v) Determining the maximum amount of appropriation for a state agency or
11 institution each fiscal year is the prerogative of the General Assembly.
12 This is usually accomplished by delineating such maximums in the
13 appropriation act(s) for a state agency or institution. Further, the General
14 Assembly has determined that a state agency or institution may operate more
15 efficiently if some flexibility is provided to the state agency or
16 institution authorizing broad powers under this section. Therefore, it is
17 both necessary and appropriate that the General Assembly maintain oversight
18 by requiring prior approval of the Legislative Council or Joint Budget

32 *revenue funds each fiscal year to the following:*

 5 (b) The funds and fund accounts in subsection (a) of this section shall be
 6 disbursed monthly in accordance with each fund or fund account's
 7 proportionate share of the total of all such allocations.
 8 (c) The provisions of this section shall be in effect only from July 1,
 9 2026 through June 30, 2027.

 11 SECTION 75. SPECIAL LANGUAGE – CODE AMENDMENT. Arkansas Code § 27-22-
 12 209(d), concerning the motor vehicle registration reinstatement fee collected
 13 by the Department of Finance and Administration after registration is
 14 suspended for operating a motor vehicle without insurance coverage, is
 15 amended to read as follows:

16 (d) The reinstatement fee collected by the department shall be
 17 ~~distributed under § 27-16-808~~ deposited into the State Treasury, and the
 18 Treasurer of State shall credit these proceeds as general revenue to the
 19 various funds in the respective amounts to each to be used for the purposes
 20 provided in the Revenue Stabilization Law, § 19-20-101 et seq.

21
 22 SECTION 76. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
 23 authorized by this act shall be limited to the appropriation for such agency
 24 and funds made available by law for the support of such appropriations; and
 25 the restrictions of the State Procurement Law, the General Accounting and
 26 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
 27 Procedures and Restrictions Act, or their successors, and other fiscal
 28 control laws of this State, where applicable, and regulations promulgated by
 29 the Department of Finance and Administration, as authorized by law, shall be
 30 strictly complied with in disbursement of said funds.

 32 SECTION 77. LEGISLATIVE INTENT. It is the intent of the General
 33 Assembly that any funds disbursed under the authority of the appropriations
 34 contained in this act shall be in compliance with the stated reasons for
 35 which this act was adopted, as evidenced by the Agency Requests, Executive
 36 Recommendations and Legislative Recommendations contained in the budget

1 manuals prepared by the Department of Finance and Administration, letters, or
2 summarized oral testimony in the official minutes of the Arkansas Legislative
3 Council or Joint Budget Committee which relate to its passage and adoption.
4

5 SECTION 78. EMERGENCY CLAUSE. It is found and determined by the
6 General Assembly, that the Constitution of the State of Arkansas prohibits
7 the appropriation of funds for more than a one (1) year period; that the
8 effectiveness of this Act on July 1, 2026 is essential to the operation of
9 the agency for which the appropriations in this Act are provided, and that in
10 the event of an extension of the legislative session, the delay in the
11 effective date of this Act beyond July 1, 2026 could work irreparable harm
12 upon the proper administration and provision of essential governmental
13 programs. Therefore, an emergency is hereby declared to exist and this Act
14 being necessary for the immediate preservation of the public peace, health
15 and safety shall be in full force and effect from and after July 1, 2026.
