22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 20. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SPECIAL MAINTENANCE. The funds appropriated in the Conservation Tax Operations

1 appropriation section of this act for the Division of Arkansas State Parks
2 Special Maintenance shall be expended, after receiving prior approval by the
3 Arkansas Legislative Council or Joint Budget Committee, for a special
