Approval of Minutes for the February 7, 2022, February 8, 2022, and February 16, 2022, Meeting Minutes [EXHIBITS C1-C3]

Representative Evans made a motion to approve the minutes, seconded by Representative Love, and without objection, the motion carried.

Recommendation Regarding Adequacy Funding Health Insurance Adjustment

Mr. Johnny Key, Secretary, Department of Elementary and Secondary Education (DESE), and Mr. Greg Rogers, Chief Financial Officer, DESE, presented the recommendation to approve an increase of \$64 to the per-pupil foundation funding amount for the 2022-2023 school year. Resulting in each school district contributing a total of \$300 per month per participating employee for public school employees' health insurance beginning January 1, 2023. Mr. Key requested amount be adopted as an addendum to the 2020 Adequacy Study to be sent to the Speaker of the House and the President Pro Tempore of the Senate in order to accomplish the purposes of continuing the adequacy evaluation required by Arkansas Code § 10-3-2104 and in accordance with Act 111 of 2022.

Representative Cozart made a motion to approve the recommendation, seconded by Representative Love, and without objection, the motion carried.
