SUMMARY OF ACTION OF THE FIRST EXTRAORDINARY SESSION OF THE 77TH GENERAL ASSEMBLY

The First Extraordinary Session of the 77th General Assembly convened at 5:00 p.m. on Tuesday June 20, 1989 and adjourned on June 23, 1989. The session was required to be called in order to reenact all 1989-91 biennial appropriations which had been ruled invalid by the Arkansas Supreme Court. The call contained 285 items, of which 284 were appropriations.

The 1989-91 biennial appropriations were enacted with the same content as they were approved by the Governor during the regular session with the following exceptions:
