PROCLAMATION

TO ALL TO WHOM THESE PRESENTS SHALL COME - GREETINGS:


- WHEREAS,* an extraordinary occasion has arisen making it necessary to convene the 86th General Assembly into extraordinary session; and
- WHEREAS,* the State of Arkansas is rich in natural resources that enhance the economic well-being of the State and provide jobs and other economic benefits for the people; and
- WHEREAS,* the natural gas deposits found in the state represent a significant natural resource that must be managed carefully and extracted wisely to insure that depletion of this scarce resource is done responsibly and with the appropriate returns to the people from natural gas severed from the state; and
- WHEREAS,* it is now necessary to increase the current severance tax levied on natural gas as the tax has not been increased since 1957 rendering the tax lower than surrounding states that are reaping the benefits and income from this natural resource; and
- WHEREAS* the revenue from the severance tax on natural gas should rightfully be invested in much needed repair, construction, maintenance and expansion of the state's highways by distributing the revenue to the Arkansas Highway and Transportation Department and to the cities and counties for roads and highways; and
- WHEREAS,* there is an immediate and pressing need to provide additional state revenue necessary to pay for essential and critical state services by replacing the existing general revenue that will be lost from the repeal of the existing severance tax; and
- WHEREAS,* due to an inadvertent drafting error in the text of Act 441 of 2007, there exists confusion in the law as it relates to the minimum age to marry in Arkansas; and
- WHEREAS,* in Act 395 of 2007, the General Assembly set certain deadlines regarding the achievement of "unitary" status by school districts in Pulaski County, and those deadlines may need to be extended due to the congested trial calendar of the court supervising the Pulaski County desegregation case;
- NOW THEREFORE,* I, Mike Beebe, Governor of the State of Arkansas, by virtue of the power and authority vested in me by the Constitution of this State, Article VI, Section 19, do hereby call an Extraordinary Session of the General Assembly to convene at the seat of government in the State Capitol on March 31, 2008, at 12:00 p.m., and I do hereby specify that the General Assembly is convened to consider, and, if so advised, enact laws for the following purposes:

1. To appropriate funds to pay the expenses and per diem of this Extraordinary Session of the General Assembly for the House of Representatives and the Senate and to amend Act 3 of 2007 to increase expenditure limits.
2. To confirm gubernatorial appointees.
3. To consider legislation providing for an increase in the severance tax levied on natural gas; providing that all taxes, penalties, and costs collected by the Director of the Department of Finance and Administration from the severance tax on natural gas shall be deposited in the state treasury and shall be distributed five percent (5%) to general revenues and ninety-five percent (95%) as special revenues to be distributed as provided in the Arkansas Highway Revenue Distribution Law, Ark. Code Ann. §27-70-201 *et seq.*
4. To consider an amendment to Act 395 of 2007 regarding the date school districts under the Pulaski County Desegregation Case are eligible for reimbursement based on unitary status declared by the federal district court.
5. To consider legislation that would repeal Act 441 of 2007, and reinstate the provisions of the Arkansas Code affected by Act 441.

Governor Mike Beebe presented to the General Assembly by Speaker Benny C. Petrus.

Address by Governor Beebe

Thank you Mr. Speaker, Mr. President. Thank you for the invitation to address this joint session of the General Assembly called into extraordinary session.

First, let me offer my thanks to all of you all for taking time out of your otherwise very, very busy lives and to come on relatively short notice to do the people's business. I know you have other duties; I know you have other responsibilities. I know that it is a sacrifice for you to set aside your own private business and your own affairs back in your own home communities to come on this occasion to address these issues. And so I am very grateful and I don't take that lightly.

This General Assembly, the 86th General Assembly, has addressed, to the great benefit of the people of Arkansas, two of this State's long standing, public-policy challenges:

You have approved a budget that sets us firmly on the path toward providing excellence in education for our children, and in doing so earned our release from the court supervision and placed us firmly on the path toward excellence in our public schools.

And while we still have a commitment for and work to do on cutting the rest of the sales tax on food, you have cut that in half, it is the State's most punitive and regressive tax- the sales tax on groceries- and you have already cut that in half when nobody for fifty years was able to do that. Either of these achievements would have been sufficient to mark this group as one of the most accomplished in recent history, but your determination in tackling both those issues is a feat for which each one of you and your constitutes back home can be very proud.

But today, you come together to address another policy question of historic significance to the State of Arkansas.

At three-tenths of 1 cent per thousand cubic feet, Arkansas's severance tax on natural gas provides inadequate compensation to the people of this State for the removal of such a valuable, non-renewable natural resource.

Legislators and Governors have wrestled with this issue unsuccessfully for more than 50 years.

You know we speak often of managing our natural resources to the benefit of future generation and in this case it is never been more important for us to keep our word. We must remember that we are negotiating on their behalf and ensuring that we are receiving just compensation that can be invested for the benefit of Arkansans – both present and future.

Now, there is a balance that must be struck: The development of the Fayetteville shale play is already paying huge dividends to our State, and we cannot afford to discourage the billions of dollars in investment that we anticipate will continue to be forthcoming in the years ahead.

The jobs already created and to be created will generate billions of dollars in economic activity and create millions in additional revenue for our State and her people.

My goal throughout the entire discussion of this issue and discussions with the industry has been to find that middle ground that provides a solution that is fair to

Arkansas and to Arkansans but does not create a disincentive for the investment of that industry in making our State the economic engine.

Now, the bill has been submitted for your consideration and the one that has been submitted to you, in my humble opinion, does both. It strikes that balance and I ask you to give it your support.

This proposal is a rare opportunity to create a new funding source for highway improvement in Arkansas without increasing the tax burden on the majority of everyday Arkansans.

Highways are critical to our economic-development strategy: Good roads are one of the most important things government can provide as incentive for job creation and for business investment.

While this solution alone will not erase the funding gap we face in addressing our highway needs, it will provide much needed capital for maintenance and repair – especially of our bridges – as well as for expansion and new construction where we need it the most.

We cannot forget that these projects create economic expansion and jobs for our people as well.

I've been told, many times, and I know many of you have heard as well, that the money that we appropriated for highways in last year's general session allowed many contractors to run full crews through the summer – providing both needed highway repairs and much needed jobs for Arkansans.

So this bill is not an "either-or" proposition.

We are encouraging the gas industry to continue to invest in exploration and production, and at the same time creating new economic activity in the construction industry.

It's a prudent, targeted approach designed to turn one economic windfall into additional expansion of our State's economy.

Opportunities such as this one appear very infrequently, so when they do arrive, we must make the most of them.

You have already made, as I indicated earlier, historic strides towards excellent education for our children and tax relief on the necessities of life for everyday Arkansans.

Now, I call on you to take one more step, one that 24 legislatures before you could not take, one that will benefit all Arkansans today and build a strong infrastructure for the Arkansas of tomorrow.

Let's do it.
