# STATE OF ARKANSAS EXECUTIVE DEPARTMENT PROCLAMATION

TO ALL TO WHOM THESE PRESENTS SHALL COME - GREETINGS:

WHEREAS: An extraordinary occasion has arisen, making it necessary to convene the 89<sup>th</sup>

General Assembly into extraordinary session; and

WHEREAS: There is a need for additional revenue to facilitate the availability of additional prison beds and to address problems caused by a large number of State prisoners currently held in local detention facilities while awaiting transfer to State facilities; and

WHEREAS: There is a need to adopt legislation to improve the financial viability of the Public Scholl Employee Health Insurance Program.

NOW THEREFORE, I, MIKE BEEBE, Governor of the State of Arkansas, by virtue of the power and authority vested in me by Article 6, Section 19 of the Arkansas Constitution, do hereby call an Extraordinary Session of the General Assembly to convene in Little Rock on Monday, June 30, 2014, at 4:00 p.m., and I do hereby specify that the General Assembly is convened in such Session to consider, and, if so advised, enact laws for the following purposes:

- 1. To provide for the payment of expenses and *per diem* of the House of Representatives and the Senate for this Extraordinary Session.
- 2. To amend the Revenue Stabilization Law to provide additional funds to the Department of Correction to finance an increase in the number of prison beds available for State inmates and address problems caused by an increase in the number of State prisoners held in local detention facilities while awaiting transfer to State facilities.
- To enact legislation to eliminate part-time employees from eligibility to participate in the Public School Employee Life and Health Insurance Program beginning in the 2015 plan year.

- 4. To enact legislation modifying the membership of the State and Public School Life and Health Insurance Board and the Benefits and Drug Utilization and Evaluation Subcommittees of the Board, requiring that certain individuals participating in the insurance plan establish health savings accounts, requiring the Board to verify the eligibility of dependents for coverage, requiring the Board to require school districts to use certain indentified FICA savings for employee premium assistance, modifying the definition of "dependents" who are eligible for coverage, and placing limits on the Public School and State Employee Health Benefit Plans' coverage for the treatment of morbid obesity and bariatric surgeries.
- 5. To confirm gubernatorial appointees.

# STATE OF ARKANSAS EXECUTIVE DEPARTMENT PROCLAMATION

TO ALL TO WHOM THESE PRESENTS SHALL COME - GREETINGS:

WHEREAS: An extraordinary occasion has arisen, making it necessary to convene the 89<sup>th</sup>

General Assembly into extraordinary session; and

WHEREAS: By proclamation issued June 30, 20414, and pursuant to Article 6, Section 19 of the Arkansas Constitution, I convened an Extraordinary Session of the 89<sup>th</sup> General Assembly to convene on June 30, 2014, at 4:00 p.m., to include five separate items for consideration during such Extraordinary Session; and

WHEREAS: There is a need for clarification as to whether the Arkansas Scholarship Lottery

Act permits the operation of multidraw screen-based lottery games.

NOW THEREFORE, I, MIKE BEEBE, Governor of the State of Arkansas, by virtue of the power and authority vested in me by Article 6, Section 19 of the Arkansas Constitution, do hereby amend my June 24, 2014, Proclamation calling for an Extraordinary Session of the General Assembly to specify that the General Assembly may also consider and, if so advised, enact is convened in such Session to consider, and, if so advised, enact laws for the following additional purpose:

6. To amend the Arkansas Scholarship Lottery Act to define and prohibit the use of "multidraw screen-based lottery games" as part of the Arkansas Scholarship Lottery.

Speaker Carter's address to the 89th General Assembly:

I would like to begin by first thanking the staff of the Old State House Museum for helping us make this a reality.

Special thanks to Director Bill Gatewood, Site Manager Ed Garretson, Education Director Georganne Sisco, and Matt Rowe with the museum's communication office.

This is not just an important day for us but for the museum as well. I just came from a press conference where the museum announced it has again received accreditation by the American Alliance of Museums. A recognition that only 3% of all museums in the country can boast.

Since we announced our change of venue for this Special Session, many of you may have already been reading up on its history. But for those who don't know, let me tell you a little about the significance of this building.

When work began on the State House in 1833, Arkansas was still mostly a wilderness and Little Rock boasted a humble collection of log cabins. But the people of Arkansas chose to house their new government in a building reflecting the glory and democracy of ancient Greece. Material for the building was gathered locally and bricks were made onsite.

This building was the birthplace of our state government. Inside these walls, our predecessors debated slavery, succession, and suffrage. Outside these walls, there is a canon reminding us of the Brooks-Baxter war where violence erupted over who was our Governor as this state entered Reconstruction.

The history hasn't always been pretty and this building hasn't always been in this exquisite.

In 1890, the only complimentary thing said about the appearance of the building in the *Guide to Little Rock*, published in 1890, was "The prettiest thing about the State House is the lovely little park in front of it."

And when the legislature did move to our current state Capitol, the Governor was quoted as saying the appearance of the Senate Chamber here was that of an old coal bin.

But Arkansas did not give up on this building. When state government moved into the new capitol building in 1912, members of the Legislature threatened to sell the Old State House. To forestall such efforts, Secretary of State Earl Hodges, gave space in the building to the University of Arkansas Medical Department.

Pioneering work of worldwide significance in malaria eradication occurred while The Old State House was home to the state's medical school. The legislature voted in 1947 for the Old State House to become a museum.

The world now knows this as a famous backdrop. It was here that Bill Clinton announced his candidacy for the presidency, and later celebrated his victory on election night in 1992.

Today, the Old State House Museum is the oldest standing state capitol building west of the Mississippi River.

The Old State House was placed on the National Register of Historic Places in 1969, and it was declared a National Historic landmark in 1997. The American Association of Museums renewed the museum's accreditation in 2003. And as I mentioned before, they were given this honor again this week.

And finally, it was here were our existing constitution was signed. A document that begins with "We, the People of the State of Arkansas, grateful to Almighty God for the privilege of choosing our own form of government; for our civil and religious liberty; and desiring to perpetuate its blessings, and secure the same to ourselves and posterity; do ordain and establish this Constitution."

Thank you to everyone who helped make this happen, let's continue to make our state proud with the work here in the next few days.
