Review of the Development and Utilization of Arkansas Comprehensive School Improvement Plans (ACSIP)

## Presenter & Synopsis:

**Mr. John Hoy**, Assistant Commissioner, Division of Academic Accountability, Arkansas Department of Education, was recognized. Mr. Hoy addressed a list of questions developed by the Bureau of Legislative Research (BLR) for response by the ADE. He discussed whether or not the ACSIP process in its current format is a valuable tool for school improvement. He addressed concerns, including the value of plans, the quality of plans, the impact of the Elementary and Secondary Act (ESEA) Flexibility Plan, and the use of student data. Mr. Hoy also covered monitoring and incorporating scholastic audit findings into plans.

#### Issues Included in the Discussion:

- deadline for ACSIP,
- adjusting the school improvement plan to the process,
- responsibility and providers for supplemental educational services,
- cost of a scholastic audit for a school,
- scholastic audit of an Alternative Learning Environment (ALE) school,
- grants available for a school to pay for an audit,
- parental involvement plans included in the ACSIP,
- monitoring of parental involvement plans,
- history of incorporating scholastic audits into school district policies,
- seeing evidence of parental involvement and/or engagement,
- impact of cultural and economic differences on parental involvement plans,
- limitations in the ACSIP software,
- comparison of average teacher salaries in Arkansas and surrounding states,
- focus and priority schools broken out with average salaries for comparison,
- looking at totality of school system for salary comparisons,
- checking on non-proficient students in the classroom,
- best practices around the use of National School Lunch Act (NSLA) money,
- availability of professional evaluation data for ACSIP,
- current compliance document/process not in the vein of W. Edwards Deming's philosophy of total quality management,
- assessment of ACSIP working better today than prior to 2007,
- addressing the unintended consequences of legislation enacted by the General Assembly,
- monitoring the overlap of functions within the department regarding compliance measures,
- developing "difference-making" metrics,
- evolution of ACSIP model,
- ACSIP and student success,
- communicating with the school board, and
- relevancy of compliance document.

## Relevant Action:

Representative McLean suggested that an ad hoc committee or subcommittee be identified to form an efficiency plan to make the ACSIP policy more practical, to report back to the Committees, and to have recommendations available for legislators in the 90<sup>th</sup> General Assembly.

Discussion of Methodologies for Conducting Adequacy Studies

#### Presenter & Synopsis:

**Dr. Brent Benda**, Senior Research Specialist, Policy Analysis and Research Section, Bureau of Legislative Research, was recognized. Dr. Benda stated the threefold purpose of this report is to provide a very succinct historical overview of the evolution of the concepts of *equity* and *adequacy*, a brief description of these concepts, and a critique of methodologies currently used to evaluate educational adequacy in states. His report covered court decisions regarding education finances, and methods of measuring and determining adequacy, including 1) evidence-based model, 2) professional judgment model, 3) successful schools model, and 4) cost function (or statistical) model. Dr. Benda commented on the advantages and weaknesses each of these methodologies offers in comparison with the other methods.
