21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
22

23 SECTION 1. Arkansas Code § 6-20-2305(a)(2), concerning per-student
24 foundation funding amounts, is amended to read as follows:

25 (2)(A) For the ~~2017-2018~~ 2019-2020 school year, the foundation
26 funding amount is equal to ~~six thousand seven hundred thirteen dollars~~
27 ~~(\$6,713)~~ six thousand eight hundred ninety-nine dollars (\$6,899) multiplied
28 by the school district's average daily membership for the previous school
29 year.

30 (B) For the ~~2018-2019~~ 2020-2021 school year and each
31 school year thereafter, the foundation funding amount is equal to ~~six~~
32 ~~thousand seven hundred eighty-one dollars (\$6,781)~~ seven thousand eighteen
33 dollars (\$7,018) multiplied by the school district's average daily membership
34 for the previous school year.

36 SECTION 2. Arkansas Code § 6-20-2305(b)(2)(A), concerning per-student



1 categorical funding amounts for alternative learning environments, is amended
2 to read as follows:

3 (2)(A)(i) For each school year, alternative learning environment
4 funding shall be ~~four thousand six hundred forty dollars (\$4,640)~~ four
5 thousand seven hundred dollars (\$4,700) multiplied by the number of
6 identified alternative learning environment students enrolled during the
7 previous school year.

8 (ii) Funding for students in alternative learning
9 environments shall be distributed based on rules promulgated by the State
10 Board of Education.

11
12 SECTION 3. Arkansas Code § 6-20-2305(b)(3), concerning per-student
13 state categorical funding amounts for English-language learners, is amended
14 to read as follows:

15 (3)(A) For ~~each~~ the 2019-2020 school year, funding for students
16 who are identified as English-language learners shall be ~~three hundred~~
17 ~~thirty-eight dollars (\$338)~~ three hundred forty-five dollars (\$345) for each
18 identified English-language learner.

19 (B) Funding for English-language learners shall be
20 distributed to public school districts for students who have been identified
21 as not proficient in the English language based upon a state-approved English
22 proficiency assessment instrument.

23 (C) Funds allocated for English-language learners to
24 public school districts under this subchapter shall be expended only for
25 eligible activities as identified in current rules promulgated by the State
26 Board of Education and are a supplement to funding for national school lunch
27 students provided in subdivision (b)(4) of this section.

28 (D) For the 2020-2021 school year and each school year
29 thereafter, funding for students who are identified as English-language
30 learners shall be three hundred fifty-two dollars (\$352) for each identified
31 English-language learner.

33 SECTION 4. Arkansas Code § 6-20-2305(b)(5), concerning per-student
34 state categorical funding amounts for professional development is amended to
35 read as follows:

36 (5)(A) For ~~each~~ the 2019-2020 school year, professional

1 development funding shall be equal to an amount of up to thirty-two dollars
 2 and forty cents (\$32.40) multiplied by the school district's previous school
 3 year average daily membership.

4 (B) For the 2020-2021 school year, professional
 5 development funding shall be equal to an amount of up to forty dollars and
 6 eighty cents (\$40.80) multiplied by the school district's previous school
 7 year average daily membership.

8 ~~(B)(C)~~ Funding for professional development for teachers
 9 in Arkansas public schools required under the Teacher Excellence and Support
 10 System, § 6-17-2801 et seq., other law or rule, or by the school district
 11 shall be used for professional development activities and materials that:

12 (i) Improve the knowledge, skills, and effectiveness
 13 of teachers;

14 (ii) Address the knowledge and skills of
 15 administrators and paraprofessionals concerning effective instructional
 16 strategies, methods, and skills;

17 (iii) Lead to improved student academic achievement;
 18 and

19 (iv) Provide training for school bus drivers as
 20 outlined in rules promulgated by the Commission for Arkansas Public School
 21 Academic Facilities and Transportation.

22 ~~(C)(i)(D)(i)~~ Additional For the 2019-2020 and 2020-2021
 23 school years, additional funding up to twelve million five hundred thousand
 24 dollars (\$12,500,000), provided for professional development above the amount
 25 in ~~subdivision~~ subdivisions (b)(5)(A) and (B) of this section shall be used
 26 by the Department of Education for the development and administration of
 27 professional learning communities for the benefit of public school districts.

28 (ii)(a) The Department of Education shall promulgate
 29 rules to administer the additional professional development funding under
 30 subdivision ~~(b)(5)(C)(i)~~ (b)(5)(D)(i) of this section.

31 (b) The Department of Education may partner
 32 with or choose a person, firm, corporation, or education service cooperative
 33 to provide the knowledge, skills, experience, and expertise for the
 34 development of a research-based process for the implementation of
 35 professional learning communities.

1 SECTION 5. Arkansas Code § 6-20-2309 is amended to read as follows:
 2 6-20-2309. Enhanced transportation funding.

3 For the ~~2017-2018~~ 2019-2020 school year and the ~~2018-2019~~ 2020-2021
 4 school year, in addition to the foundation funding provided to a school
 5 district under § 6-20-2305(a)(2), the Department of Education shall
 6 distribute enhanced transportation funding to school districts each school
 7 year in the following amounts:

SECTION 6. EMERGENCY CLAUSE. It is found and determined by the
General Assembly of the State of Arkansas that funding for public schools is
the obligation of the state; that ensuring that adequate funding is provided
is the duty of the General Assembly; and that this act is immediately

1 necessary to ensure that funding is provided for the 2019-2020 and 2020-2021
2 school years so that school districts can budget accordingly. Therefore, an
3 emergency is declared to exist, and this act being immediately necessary for
4 the preservation of the public peace, health, and safety shall become
5 effective on:

6 (1) The date of its approval by the Governor;

7 (2) If the bill is neither approved nor vetoed by the Governor,
8 the expiration of the period of time during which the Governor may veto the
9 bill; or

10 (3) If the bill is vetoed by the Governor and the veto is
11 overridden, the date the last house overrides the veto.
